Train Happenings:

One of the most notable structures we encounter on our trip with the Charlie Russell Dinner Train is the Sage Creek/Hoosac Tunnel. The tunnel as approximately 2,014 feet long and stands an average of 20 feet high. The tunnel is arched so it is higher in the middle (21 feet) than on the sides (16.5 feet). Before I tell you any more, I want to first calm your fears. While we are traveling through the tunnel we slow the train down to around 5 to 8 mph, we keep all hands, feet, and loose articles of clothing secure during passage, and we have an outstanding success rate of 100% for traveling through the tunnel without incident.

Continuing on. The tunnel construction began in 1912 by Twohy Brothers Company out of Portland, Oregon in August of 1912. (1) They began construction on both the east and west sides, the majority of all the work was done by hand and some steam shoveling. They used teams of horses to create the 0.5% grade through the tunnel. The different soil and rock types they encountered slowed their progress. Once complete they used timber to line the tunnel and the tracks reached Denton in October of 1913. (2)

Lining the tunnel with concrete was done soon after the completion of the tracks and the tunnel was easily maintained for the next 70 years. Easily maintained in this case could mean really just sticking to that 100% success rate of travel, because, when Central Montana Rail took control of the tracks in the early 1980's the damage caused by permeable soils and drainage issues had left a portion of the track collapsed and water along the track bed. Don't let that fear creep back in; CMR overhauled the drainage system, repaired the concrete, and laid new track in the 1980's rehabilitation project. (3)

The Sage Creek/ Hoosac Tunnel is in my opinions is the most unique feature on our journey with the dinner train. To see the tunnel first hand, call us at the Chamber to book your ride!

In lieu of coupons we are sharing information on the COVID-19 recommendations for employers

In advance of employee illness:

- Determine whether flex working is an option.
- Create an employee communications plan: Establish a process to communicate the latest Coronavirus information to employees and business partners. Anticipate employee fear, anxiety, rumors, and misinformation, and plan communications accordingly.
- Decide how to handle spikes in absenteeism: Determine how you will operate if absenteeism spikes from increases in sick employees, those who stay home to care for sick family members, and those who must stay home to watch their children if dismissed from school.
- Coordinate with state and local health officials: Coordination with state and local health officials is strongly encouraged for all businesses so that timely and accurate information can guide appropriate responses in each location where their operations reside. Given the intensity of an outbreak may differ according to geographic location, local health officials will be issuing guidance specific to their communities. Also, employers should take the time now to learn about plans in place in each community where they have a business by contacting their local public health department.
- Make a business continuity plan: Be prepared to change your business practices if needed to maintain critical operations (e.g., identify alternative suppliers, prioritize customers, consider digital meetings, or temporarily suspend some of your operations if needed).
- OSHA requirements: Identify possible work-related exposure and health risks to your employees. At the time, there is no specific Occupational Safety and Health Administration (OSHA) standard covering the Coronavirus. However, some OSHA requirements may apply to preventing occupational exposure to the Coronavirus. OSHA has more information on how to protect workers from potential exposures to the Coronavirus. Health confidentiality: If an employee is confirmed to have the Coronavirus infection, employers should inform fellow employees of their possible exposure to the Coronavirus in the workplace but maintain confidentiality as required by the Americans with Disabilities Act (ADA). Employees exposed to a co-worker with confirmed Coronavirus should refer to CDC guidance for how to conduct a risk assessment of their potential exposure.




